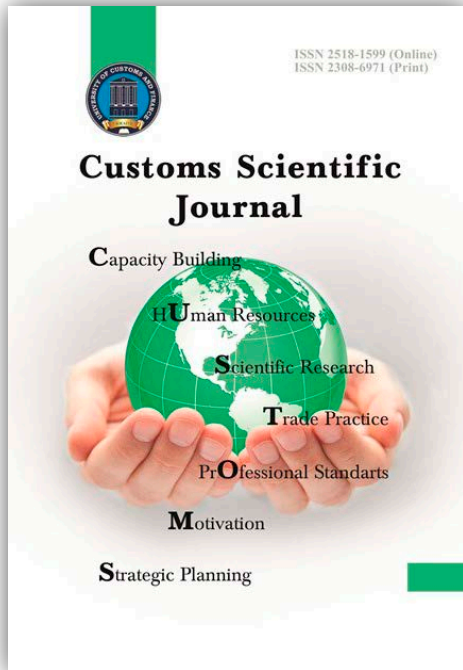

# Customs Scientific Journal



Customs Scientific Journal is a scientific and practical journal on customs and foreign economic activity, founded in 2011 by the University of Customs and Finance support of the World Customs Organization.

The journal releases scientific and review papers on the main problems of foreign economic activity, partnership of customs administrations and business entities, professional education in the field of customs, implementation and enforcement of the World customs Organization standards, review articles on experience in implementing institutional development strategies of customs administrations of member states of the World Customs Organization, works of young scientists in the field of customs and foreign economic activity, abstracts and announcements.

Employees of customs administrations, customs educational institutions, as well as research institutions of the European countries, in particular, Austria, Macedonia, Germany, Poland, Hungary, etc., are currently publishing their materials in the scientific journal. The specialized journal is one of the few in the international scientific environment to study the issues of customs regulation professionally.

### To publish an article

in the scientific journal “Customs Scientific Journal” No. 1, 2022, it is necessary to fill the information about the author at [link](#) or QR Code

and send it to [editor@csj.umsf.in.ua](mailto:editor@csj.umsf.in.ua) on or prior to **April 15, 2025** with the following documents:

- scientific article (Surname.doc);
- a copy of a receipt of payment the publication fee (the payment is made only after editors accept the article for printing).

The email should have the subject “Article to the journal “Customs Scientific Journal. No. 1, 2022” (to indicate the issue number the article is submitted to).

The authors will be notified about the receipt and review of the scientific journal by the Editorial Board by e-mail.

*Please note!* If you have not received a confirmation letter in 5 business days, please appeal to the editors using **contacts**.

All the articles are checked for plagiarism using the StrikePlagiarism.com software developed by the Polish company Plagiat.pl.

The authors receive a letter about the results of the review (rejected, accepted with revisions, accepted) and, in case of successful completion, also receive details for the payment of the publication fee.

The Editorial Board do not consider articles not conforming to the requirements of submission and article’s design.

Language of the publication: **English**.

### Requirements for design of the article:

Volume – 12-20 pages of text, paper size – A4, margins (all sides) – 20 mm, spacing– 1.5, font size – 14, font – Times New Roman, paragraph – 1 sm (for the main text of the article only).

### Structure of the scientific article:

1. *UDC* (right alignment). Code identification – see <http://www.udcsummary.info/php/index.php?lang=uk>

2. *Title of the article*.

3. *Surname, name, patronymic of the author(s)* of the article (no more than 2 persons), position, affiliation, academic degree, academic rank (if any), e-mail.

4. *ORCID ID code*. If the author is not registered in ORCID, it is necessary to create the account at <http://orcid.org>.

5. *Abstract and keywords*.

Abstract volume: 300 words minimum, 350 words maximum. The required abstract structure: Purpose, Methods, Results, Conclusions. The abstract is accompanied with 5-10 keywords or phrases; none of them duplicates the article’s title.

6. *JEL Classification* for keywords.

7. *Text of the article*.

*Introduction* is an obligatory part of the article where the author indicates novelty of the topic and relevance of scientific solutions. The purpose of the study should be clearly indicated along with the research objectives. It is necessary to indicate the research methodology, the logic of the presentation of the studied material.

The main text should be divided into meaningful sections with separate titles (up to 4-6 words).

The article should contain *Conclusions* from the study where to indicate detailed specific conclusions based on the results of the study and prospects for further research in this direction.

8. *References*. This part is organized in accordance with the APA Style Reference Citations. Author (transliterated), title of the article (transliterated), title of the article (title translated in English in square brackets), title of the source (transliterated), source data (city in English), publisher (transliterated). Example:

Transliteration of names and surnames in Ukrainian is performed according to the requirement of the Resolution of the Cabinet of Ministers of Ukraine No. 55 “On Normalization of Transliteration of the Ukrainian Alphabet by Means of the Latin Alphabet” dated January 27, 2010.

Transliteration from Russian is performed according to GOST 7.79-2000. System of standards on information, librarianship and publishing. Rules of transliteration of Cyrillic script by Latin alphabet.

9. At the end of the article, the following information should be mentioned *in Ukrainian*:

- title of the article;
- surname, name, patronymic of the author(s) of the article (no more than 2 persons);
- position, affiliation, academic degree, academic rank (if any), e-mail;
- ORCID ID code. If the author is not registered in ORCID, it is necessary to create the account at <http://orcid.org>;
- abstract and keywords;

Volume of abstract in Ukrainian: 300 words minimum, 350 words maximum. The required abstract structure: Purpose, Methods, Results, Conclusions. The abstract is accompanied with 5-10 keywords or phrases; none of them duplicates the article's title.

#### **Rules of link on references and bibliographic description design:**

References are given in the text only in parentheses according to the example:

Many researchers have considered the issues of theory and implementation of international

customs law's standards in their publications, thus the analysis of existing developments in the sphere of scientific research indicates the diversity of views upon their understanding. The generalization of published scientific papers allows us to combine the existing diversity of views in understanding the standards of international customs law within the framework of two approaches: scientific and practical (Baimuratov, 2006).

#### **Cost of publication:**

The publication fee for release of the article in the scientific journal including its printing and sending of one author copy is:

- 1000 UAH for an article of 12 pages for Ukrainian citizens. Each additional page should be paid extra 50 UAH;
- 50 USD for an article of 12 pages for foreigners. Each additional page costs extra 2 USD.

Additional copy of the journal costs 200 UAH.

Foreign authors will be notified of the terms of payment additionally when contacting the editorial team.

The editorial team accepts scientific articles by Doctors of Sciences from foreign countries (provided that only the electronic version of the journal is available) free of charge.
